James Heideman made a motion, that was seconded, to approve the Provision Data Solutions 2026 Agreement. Motion carried unanimously.

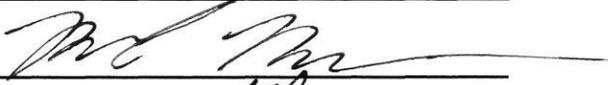
